<u>Presque Isle County Road Commission</u> – Road Projects Update

Mr. Grohowski presented the board with updated information on road projects received from Jerry Smigelski, Superintendent/Manager for the Presque Isle County Road Commission. Mr. Smigelski stated projects may not be completed this year due to the commission's work load and a financial position limiting their ability to extend a payment schedule to the township. The commission may have to do piece work. His proposed agreement, based on two payments, does not include Hill Street and is at an estimated cost of \$150,000, with the township's share to be \$112,500. Longevity of asphalt surface is estimated to be 15 to 20 years. Township will consider paying for work as completed. The board will further review the proposed contract.

<u>Transfer Station Project</u> – Clean & Paint

Mr. Grohowski has received a quote on power washing and painting the transfer station from Bliss Painting in the amount of \$2,084.80. Moved by Diane Mucciante, supported by Michael T. Smith, to accept the quote from Bliss Painting in the amount of \$2,084.80 to power wash and paint the transfer station and approve a deposit payment of \$521.00 to be paid from the maintenance & improvement fund to start the project.
