<u>Planning Commission</u> – Roger K. Witherbee

Mr. Witherbee filed the minutes of a public hearing on the Light Industrial Ordinance and Site Plan & Development Standards for Light Industrial, and a regular meeting held on December 17, 2015. The Light Industrial Ordinance and Site Plan & Development Standards have been submitted to the Township Board. At the regular meeting the Commission reviewed "tiny houses." The Commission noted that square footage is covered in Article XIV and perhaps the County should address the issue.
