From Your Supervisor:

Your Supervisor has graciously allowed this newsletter to go out without a personal message to accommodate the following:

Recycling Station: The township has no operational decisions on the recycling station. We only allow a place to put the bins. This program is operated by the County. Please do not leave items that do not fit in the dumpster. If the dumpster is full, there are additional bins located at Presque Isle Township Hall and Posen Village Hall (by E&T's). Any questions, concerns or recommendations need to be directed to Darin Darga, Presque Isle County Clerk. The number for that office is 989-734-3288

Zoning and Building Permits: This is the season for building and improving. Please make sure to contact our Zoning administrator as indicated below.

From Your Treasurer:

The direct line for the treasurer is 989-590-8049. She will be at her computer and ready to answer questions from 8am – 9am; Monday – Friday, excluding federal holidays. The number will be active all day. Only calls with a message left will be returned. All calls received after 9am will be answered the following business day. The most efficient way to contact the treasure is through email or text.

Summer Tax bills are due from 7/1/2025 thru 9/15/2025. The treasurer will be at the township hall on 9/15/2025 to accept payments in person. Cash payments must be exact change.

- A drop box for payments has been installed at 7624 Grand Point Road, Presque Isle, MI. Please use the drop box and not the mailbox. The drop box is secure. Payments are not accepted at the door.
- Credit card payments can be made online. Please send an email to treasurer@krakowtownship.org. This email needs to have subject line of "Tax Invoice Request". Email needs to list the parcel numbers of all parcels to be included. You will receive 2 invoices. First will be the total tax owed. The second will be an invoice for the 3.5% service fee for processing the taxes. Both emails will include links to process payment. ALL invoices will state "Krakow Township". Both must be paid before taxes are processed and posted. All tax payments paid with credit cards will receive a receipt. If the service fee is not paid, payment will be returned.
- Postmark is not the date of payment. The date of payment is the date received. Each payment will be stamped at receipt and processed during regular business hours. Please send an email if payment is not processed within 10 business days.
- All payments without payment slips must have an accurate detail of what check is covering. We will process as indicated. When in doubt it will be returned to sender.
- **Post Dated Checks will be returned immediately.**
- Summer Taxes can only be collected from 7/1/2025 through 2/28/2026. If payment is not able to be received by 2/28/2026, please forward to the County Treasurer.
- Receipts are sent by request only unless they are paid by credit card.
- 20% of our properties are re-inspected every year to have a complete reinspection of the township completed every 5 years. If you have any questions, please contact our assessor.
